2. Collection and storage of personal data as well as type and purpose and their use

3. Transfer of data to third parties

4. Rights of the data subject

You have the right

- if you have given your consent, you have the right to withdraw your consent to the data processing body at any time in accordance with Art. 7 Paragraph 3 GDPR. This means that the data processing based on this consent may no longer be continued in the future;
- in accordance with Art. 15 GDPR, information about your data from the data processing body processed personal data. In particular, you can request information about
 - the purposes of processing, the category of personal data, - the categories of recipients to whom your data has been disclosed or become,
 - the planned storage period or, if specific information is not possible,
 Criteria for determining the storage period,
 - the existence of a right to rectification, erasure, restriction of processing or objection, - the existence
 of a right of appeal, - the origin of your data, unless
 it is provided by the data processing body

- to request the immediate rectification of inaccurate or completion of your personal data stored by the data processing body in accordance with Art. 16 GDPR;
